Dilute 1 part **GLASS ACT** with 5-10 parts water and apply to surface, preferably with spray atomizer. Spray small area at a time. Wipe off with clean cloth or paper towel. Turn cloth and buff dry. A window squeegee may be used if preferred.

FOR AREAS WHERE SPRAYING IS DIFFICULT

Apply **A-3180** directly to cloth, apply to the surface and wipe dry with clean cloth.

FOR EXTERIOR WINDOW CLEANING

Dilute 1 part in 80 parts water (100ml - 8L bucket). Apply solution with a soft brush, then squeegee dry.

FOR HEAVILY SOILED AREAS

For the best results, simply spray neat **A-3180** on, and wipe clean with a paper towel. No preparation of the surface is necessary.

GLASS ACT easily removes marks, smudges, fingerprints, dirt and grease. If a paper towel or spray is not available, a cloth may be dampened with neat **GLASS ACT** and the surface wiped clean. Occasionally smudging may occur with this method, it is therefore not recommended for the best results.
