DIRECTIONS FOR USE

Preliminary testing may be required on the seam before spotting. Spray directly on the stain, rub in lightly. Let product work for 5-10 minutes. Washes clothes with your usual detergent, using appropriate program for the fabric. Repeat if necessary, moistening with hot tap water.
Caution : for colors or very delicate textiles, test on hidden area first.

STORAGE & SAFETY

Two years, stored in closed original packaging in a cool and dry environment.
Avoid contact with skin and eyes. In case of contact, wash with soap and rinse skin and flush eyes with running water for at least 15 minutes. Seek medical attention if effects persist. If swallowed, DO NOT induce vomiting, give plenty of milk or water to drink. Seek medical attention.
Keep out of reach of children.
