DIRECTIONS FOR USE

- Cleaning and Remanence (0.25%):
 Dilute 1 dose 20ml with 8 liters of water
- Cleaning and Disinfection (1%):
 Dilute 2 doses 20ml with 4 liters of water
 Bactericidal: NF EN 1276
 1% in 5min 20 C in dirty conditions.

STORAGE & SAFETY

Two years stored in original packaging at ambient temperature.

If swallowed, wash mouth thoroughly with water immediately. DO NOT induce vomiting. Give milk or water to drink to dilute the swallowed chemical. Seek medical attention.

Avoid contact with the eyes; flush affected areas with copious amount of water for at least 15 minutes. Seek medical advice.

Avoid contact with the skin; wash with soap or mild detergent and flush affected areas with copious amount of water for at least 15 minutes. Seek medical advice.
