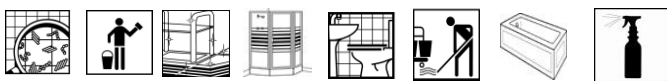


DESCRIPTION

APPLICATIONS



SANICIDE is used effectively in hospital, institutions, office buildings, schools, factories, motels, hotels, clubs, spas, and veterinarian clinics, cafeterias, restaurants and food processing plants for non-food contact surfaces. It is used anywhere germs can cause disease or malodours.

SANICIDE is recommended for floors, surfaces, toilet surfaces, urinals, changing rooms, garbage cans etc.

DIRECTIONS FOR USE

DISINFECTION : Remove heavy soil deposits from surface, then thoroughly wet surface with a solution of 2 ounces of the concentrate per gallon of water. The solution can be applied with a cloth, mop, sponge or coarse spray or soaking. Let solution remain on surface for a minimum of 10 minutes, rinse or allow to air dry. Rinsing of floors is not necessary unless they are to be waxed or polished. Food contact surfaces must be thoroughly rinsed with potable water. This product must not be used to clean the following food contact surfaces; utensils, glassware and dishes. Prepare a fresh solution daily or more often if the solution becomes visibly diluted.

USDA : For use in federally inspected meat and poultry plants on all hard, non-porous surfaces in inedible product processing areas, non-processing areas and/or exterior areas. All surfaces must be thoroughly rinsed with potable water.

For use in federally inspected meat and poultry plants as a floor and wall cleaner for use in all departments. For use as a disinfectant in all departments. Food products and packaging material must be removed from the room or carefully protected. Use product in accordance with its label. All surfaces must be thoroughly rinsed with potable water.

TOILET BOWLS : Swab bowl with brush to remove heavy soil prior to cleaning or disinfecting. Clean by applying diluted solution around the bowl and up under the rim. Stubborn stains may require brushing. To disinfect, first remove or expel over the inner trap the residual bowl water. Pour in three ounces of the diluted solution. Swab the bowl completely using a scrub brush or mop, making sure to get under rim. Let stand for 10 minutes or overnight, then flush.

MILDEWSTATIC INSTRUCTIONS : Will effectively control the growth of mold and mildew plus the odors caused by them when applied to hard, non-porous surfaces such as walls, floors, and table tops. Apply solution (2 ounces per gallon of water) with a cloth, mop, sponge or coarse spray to wet all surfaces completely. Let air dry. Repeat application weekly or when growth reappears.

STORAGE & SAFETY

Two years, stored in closed original packaging in a cool and dry environment.

GERMICIDAL INFORMATIONS

SANICIDE is a germicidal detergent and deodorant that is effective in hard water up to 400 ppm calcium carbonate or in the presence of a moderate amount of soil (5% organic serum) according to the AOAC use dilution Test. It disinfects, cleans and deodorizes in one labor saving step.
