



SPILL GONE

Safe Oil Spill Dispersant

DESCRIPTION

SPILL GONE is a high powered oil dispersant and solubiliser, used in cleaning up heavy oil and oil waste products from dock areas, harbors, decks, slips, bilges and sumps.

APPLICATIONS

SPILL GONE is used by Marinas, Dry Docks, Coastal Refineries, Off Shore Oil Rigs, Steam Ship Companies, etc.

- High Dispersion Capacity
- Does not contain any aromatic or chlorinated solvent
- Non-Corrosive to metals, including zinc, alloys and aluminium
- Safe on paint works

DIRECTIONS

For oil spillage on water (in harbors, around oil rigs, storage areas, etc) :
spray **SPILL GONE** heavily over oily areas to thoroughly cover and blend with oil. Allow natural action of waves to slowly disperse oil . For faster dispersing and clean up, wait 15 to 20 minutes for complete penetration. Spray treated areas with water from high pressure hose.

For oil spillage on dock and deck areas :

spray **SPILL GONE** over oil and allow to penetrate. Flush off with hose.

For sumps and bilges:- to emulsify and disperse bilge water and facilitate cleaning, initially add 200ml of **SPILL GONE** per 4 litres of bilge capacity, then follow up with 100ml per 4 litres of bilge water before pumping.

Two years, stored in closed original packaging at ambient temperature.
